MEDIA STATEMENT: FOR IMMEDIATE AND URGENT RELEASE.

SOME CHANGES TO STRENGTHEN THE COMPOSITION OF THE NAMIBIA AIRPORTS COMPANY'S (NAC) CURRENT BOARD OF DIRECTORS.

- 1.1. After some extensive consultations, very focussed discussions; and whereafter, sound and wise advice, was proffered; I have decided to effect some urgently needed changes, with regard to the composition of the current NAC's Board of Directors as follows:

 - (c) Mr Rudolph RITTMAN: Board Member;
 - (d)Ms Grace MUHAMED: Board Member;
 - (e) Ms Ipupa KASHEETA: Board Member.
- 1.2. The terms of Office of the NAC's Board's Chairperson and that of the Vice Chairperson of the NAC Board, take effect from 11 October 2018 and shall officially come to an end on 01 August 2019.
- Further appropriate and needed information, regarding this matter; as well as other issues, relevant to the National activities and duties of the NAC, e.g. forthcoming ICAO Audit, recruitment of NAC's Substantive Chief Executive Officer. Ondangwa Airport Contract ongoing Court Case, Walvis Bay Airport's "renovated" facilities current status, plans w.r.t. Rundu Airport etc, will be provided at a MEDIA CONFERENCE, to be scheduled as soon as practically possible.

1.4. I wish the Board Members all the succes and wisdom, in steering the most important National activities, duties and mandate of the NAC, in harmonoius working relationship with the NAC Management and Staff!
